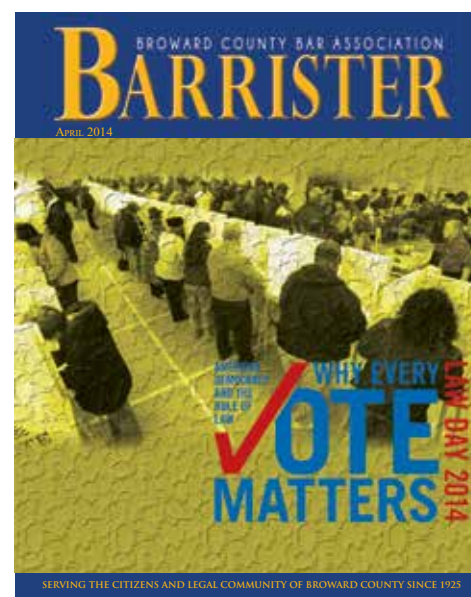

letter from the president

The percentage of attorneys practicing in Broward County who are members of the BCBA has hovered in the low 2000's as far back as anyone can remember. Building on the creative and determined efforts of the last few membership committees, this year Membership Committee Chairs, Gary Singer and Gary Landau, have worked with Braulio Rosa and our other professional staff to increase membership from 2100 in 2010 to over 2900 this year. With the help of other Board members, they have gone to the root of the problem by signing up law school students and first year attorneys and then holding events for them to

introduce to them the benefits of BCBA membership in order to develop a culture of belonging right from the start of their careers. Jeff Harris and Ken Hassett have developed new programs to make membership meaningful to Assistant State Attorneys and Public Defenders, as well as other government-employed attorneys.

I am "preaching to the choir" to those of you who receive this magazine for two reasons. The first is to urge you to renew your membership now for the new year which begins July 1, 2014. Every year we lose existing members who forget to renew because they put it off until "next month". We are learning that some associates and even partners of big firms assume that their membership is being renewed by their office managers, only to learn that it slipped through the cracks. When you see the email to renew in the next few weeks, take five minutes to do it that day. Somehow we never seem to get back to those saved emails. If you are in a firm where someone else is responsible for your renewal, take five minutes to contact them to make sure that it gets done.

The second reason is to remind you of the many benefits of membership in the BCBA so you can take full advantage of them and so you can encourage nonmembers to join. The most obvious reasons for membership are access to the many inexpensive CLE's for every practice section and the reduced attendance fees at functions such as Small Solo dinners, Law Day (May 2), Raising the Bar for family lawyers (April 11), the recent 4th DCA reception and the many other opportunities to network and to mingle with our judges. Our Lawyer Referral Service provides a steady stream of new business to our members. Members can buy units to the Clerk's Premium Access service in small quantities. Bench Bar and Clerk Bar committee members have direct access to those who run our court system. Our website lists discounts at local legal and retail merchants available to our members.

The more members we have, the greater the number and quality of programs and benefits we can offer. And then there is the most important reason of all - as attorneys we have a responsibility to be involved in the legal community to strengthen the quality of legal service to the citizens of Broward County. **B**

ELDER LAW: NOT JUST ABOUT THE ELDERLY

It is my honor to serve this year again (I think I should stop counting how many) as the Co-Chair of the Elder Law Section with long-time Chair Arlene Lakin who is certified in Elder Law and one of the foremost specialists in this field in the State of Florida. After nearly 35 years as attorney and past President of the BCBA I have begun to wonder when I cease saying I am “middle aged” and begin to think I am embarking on my “elder” years. Though I am the new kid on the block compared to some of the readers and I still respond to “young man” when I am called, I know I am late in the third quarter of a blessed career as an attorney and member of the BCBA.

I had another honor this past year volunteering and participating with the NSU Law School Class of 2013. I met with three third year students wherein I was the presumptive client and they were my attorneys. I am grateful it was a free consultation because I certainly would not be able to afford the hourly rate of consulting three attorneys at one time. I was fortunate that Michael Sharp, Jason Thomassy and Kim Tran reduced their “hourly fee” to \$200.00 in return for the quid pro quo of their becoming student members of the BCBA until such time as they pass the Bar (hopefully be on the first try) and then to enjoy their first year of attorney membership at no cost. In my opinion we can rest assured that the torch is being passed to a fine and extremely intelligent new generation of attorneys who stand on the shoulders of the giants past and take their places with dignity, pride and professionalism.

As attorneys and client, we discussed Elder Law; Guardianship and Probate, and specifically how to avoid Guardianship and how to avoid Probate. The best way to avoid probate is to simply not die; I think the second best way is to spend your money and enjoy your assets, not leaving a big estate, although I know for most of us with families including myself this is not an option. We all know the ways to avoid probate are through a Revocable Living Trust and/or joint ownership of property or titling our assets with beneficiaries. The best way to avoid a Guardianship is with advanced directives; lesser restrictive means including but not limited to a Durable Power of Attorney (remember they were revised in October 2011 and we had all those sell-out seminars where our three Probate Judges hosted); Health Care Surrogate and Living Will. During my interview I came to realize that a young person, even a very young person is a candidate for an “elder law” attorney. Families with children with special needs although far from elderly will require the expertise of an attorney familiar with ways to assist. The question arises as to whether the individual is capable of signing the lesser restrictive documents or whether a Guardianship or Guardian Advocate is required. Government benefits and job opportunities through various agencies and companies also needs to be discussed. Finally we discussed whether it is best to actually create a Guardianship rather than to avoid one.

As the interview continued we discussed a Will with Testamentary Trusts for mi-

nors vs. a Revocable Living Trust. Sometimes avoiding probate should not be our main goal. We discussed Federal Estate Tax and although my character was close he was out of reach of that situation. We also discussed Medicaid and VA benefits for my character’s aged parents who were in their 80’s and 90’s. When tax issues were brought up they quickly instructed me to discuss that with my CPA as well. I was told to include a dispositive list attached to my documents for bequests of personal property and to include a copy of my pre-arranged funeral/burial/cremation plans with my estate document and advanced directives. It was suggested I make an informal list of my assets with some back up documentation such as recent statements to become a part of the package as well.

At the conclusion of the consultation I was given an appointment to return to execute my documents and given a lecture on how I must “fund” my Trust and the consequences of if I did not do so which would defeat the whole purpose. I believe I left the meeting a better person and hope to think my “attorneys” did as well. **B**

Social Media

Social networks are all about relationships. They are about connecting and, in many cases, discovering who is connected to whom. They are about building connections and building rapport. Business development is all about relationships. At its core, social networking, like business development, is about developing relationships between an organization's representatives and its target audiences. But then, why aren't more lawyers utilizing social media to develop business?

Lawyers routinely say that LinkedIn is meant for business, while other social media platforms, like Facebook, Twitter and blogs, are for socializing with friends. LinkedIn has exploded in popularity over the last few years, due in large part to its ability to help professionals identify, qualify, and engage potential clients. However, LinkedIn is not the only platform available to lawyers who want to get in the social networking game, and those with this narrow mindset are missing the wider changes in attitude towards work and business that social networks like Facebook, and Twitter are providing.

Don't get me wrong. As a lawyer, you should definitely use LinkedIn. Build an impressive profile, connect with those you meet on and off-line, and share or comment on items of interest. But don't stop there! Rather than be guided by arbitrary thoughts that tell you one social media platform is for business and another is for plea-

sure, pick another platform that excites you and begin building relationships. There are a number of social media platforms available to help analyze, organize and develop business prospects. Use Twitter (tweet), start a blog, or connect on Facebook to learn more about the people you know, and people who you want to know better, in your business development efforts. Moreover, rather than getting stuck on buzz words and sales to build your profile, think about business development - build relationships and expand your social reach.

Create a blog: Blogging is one of the best ways to engage others, establish increased value, and develop relationships. Blogging is one of the most basic aspects of social media - the goal is to establish oneself as an expert, increase name recognition, and eventually develop continued readership. You can do that by curating and sharing relevant information and insight. When news breaks that affects your practice areas, you can quickly respond through social media and have a real-time voice in online discussions. Through your blog, you can explain your thoughts and ideas in a way that speaks to your target market, and it will become easier for you to do so during a consultation or client meeting. If you make a commitment to keeping your blog timely and relevant, you will increase your exposure to people who are searching the Internet for answers to their questions. The more content you are able to create that is relevant to a par-

ticular topic, the more online "turf" you are going to cover, and it will be much more likely that an interested prospect will continue turn to you, rather than another lawyer, for advice.

Tweet: When compared to the other social media sites that lawyers use, Twitter offers the most varied networking opportunities. On LinkedIn, most people connect only with friends, family and colleagues (i.e., people they already know), and use it mainly as a professional network, without much socializing. Twitter, on the other hand, provides access to people you do not know across the globe. By "tweeting," lawyers can send short (140 characters) messages that are seen by a wide range of people, including potential clientele. Lawyers should "tweet" about their practice area, legal opinions, and changes in the law. Although, it is important to note that certain rules and restrictions from the Bar do apply. It is best to familiarize yourself with the latest rulings on attorneys' use of social media before making a post about your practice.

Twitter also provides attorneys with a forum to connect with other attorneys and legal professionals. By following other colleagues' "tweets," lawyers can keep up with current legal trends and engage each other via Twitter to problem solve or discuss legal matters. By being able to connect with other colleagues, lawyers can increase their knowledge base and efficiently problem solve. Most

importantly, to build deeper relationships from Twitter, lawyers should check out the profile pages (on LinkedIn) of their Twitter followers, and share what others Tweet on their news feeds. Re-tweeting others' content will help you get to know your followers. Finding a balance between sharing things you enjoy, conversing with others, re-tweeting your favorite posts and sharing interesting information, is all part of building your presence online. By sharing valuable information via Twitter, lawyers can engage with a wide range of people, and build relationships with a broader array of potential clientele.

Connect offline: Online, network with professionals you meet on Twitter, via LinkedIn or blogging. If you meet people and make new connections through blogging and tweeting, connect with them on LinkedIn, send them an email, or reach out to them

via telephone. Try to get together for lunch or coffee. Offline, attend different events that are relevant to your interests. Social media should be treated as a supplement to traditional networking, as nothing can compare to real life face-to-face interaction. Attending industry conferences or charitable events, as well as getting out of the office for coffee or lunch is vital to build relationships and business development. The core purpose of these social networking tactics is to build and foster interpersonal relationships, which requires offline communications to grow.

As technology continues to change the world, the underlying principles of business-development remain unchanged. You need a human element or a network of values. The key is to keep the relationship meaningful. You need people who care about and trust the information you share on-

line. A potential client will not hire you unless he or she feels that you are trustworthy and can deliver results. A properly managed social media campaign can help build confidence by communicating a lawyer's character and reputation to potential client. Over time, once you have developed a trusting relationship, the business conversion almost becomes a natural byproduct.

Recent Developments in the Law

SUPREME COURT: NON ECONOMIC DAMAGES CAPS IN MEDICAL MALPRACTICE WRONGFUL DEATH CASE UNCONSTITUTIONAL

In a lengthy and long-awaited decision, a split supreme court held that section 766.118, Florida Statutes, violates the Equal Protection Clause of the Florida Constitution. The decedent, who died as a result of medical negligence after childbirth, left behind three surviving family members. A federal jury found they were entitled to a total of two million dollars in non economic damages, but the trial court reduced that verdict to one million based on the statutory cap limiting total non economic damages to one million dollars regardless of the number of claimants. The Eleventh Circuit affirmed but certified to the Florida Supreme Court the question of whether the statute violated any Florida constitutional provisions.

The supreme court found that the statute violated equal protection guarantees because it imposed “unfair and illogical burdens on injured parties” where the negligence gives rise to multiple claimants who, because of “arbitrarily diminished compensation,” do not receive the same rights to full compensation as do other parties. The court, in applying the rational basis test, further found that the statutory cap failed to meet that test and

did not bear a “rational relationship to the stated purpose that the cap is purported to address, the alleged medical malpractice insurance crisis in Florida.” *Estate of McCall v. United States of America*, 39 Fla. L. Weekly S104 (Fla. March 13, 2014).

SUPREME COURT: ABSENT PREJUDICE TO INSURER, INSURED’S BREACH OF COMPULSORY MEDICAL EXAM POLICY PROVISION DOES NOT RESULT IN FORFEITURE OF UM BENEFITS

Answering a certified question from the Fifth District sitting en banc, the supreme court held, 5-2, that a compulsory medical exam provision in an uninsured motorist policy is not a condition precedent to coverage. Rather, in the UM context, it is a post-loss obligation of the insured. As a result, an insured who breaches such a provision does not automatically forfeit benefits. The insurer has the burden to prove, if it can, that it was prejudiced by the insured’s breach. *State Farm Mutual Automobile Insurance Company v. Curran*, 39 Fla. L. Weekly S122 (Fla. March 13, 2014).

DISCHARGED ATTORNEY ENTITLED TO CHARGING LIEN DESPITE FACT THAT NEW ATTORNEY MAY HAVE DONE MORE WORK IN ACHIEVING SETTLEMENT

An attorney was discharged after beginning work and conducting discovery in a crashworthiness case, because the client wanted a “more aggressive” lawyer. Years later, after the new lawyer achieved a very large settlement, the first lawyer filed a motion to enforce his charging lien for the work he had done. Although it was stipulated that the amount of the lien was reasonable, the trial court denied him any recovery because it found his efforts “were dwarfed by the subsequent efforts of subsequent counsel.” The Third District granted certiorari, holding that a client’s desire to hire a more aggressive lawyer does not deprive the initially discharged attorney of entitlement to be paid for his or her work, and that “this would make charging liens all but superfluous.” *Courtney v. Hall-Edwards*, 39 Fla. L. Weekly D540 (Fla. 3d DCA March 12, 2014). **B**
